1. Landowner license applications will not be accepted by the Wyoming Game and Fish Department without the approval of the game warden within whose district the areas being applied for are located. To help verify that you are eligible as a landowner applicant, please complete the following:

* Legal description of the deeded land that entitles you to this license (section, range, township)

* Is this land held as: an individual? a corporation? a trust? a partnership? a limited liability company?
 joint tenancy or tenancy in common or tenancy by the entirety?

* If you are a member of the landowner's immediate family, what is the name of the landowner to whom you are related?

INSTRUCTIONS FOR COMPLETING REDUCED PRICE COW/CALF ELK SECTION

This section is to be used to apply for a Reduced Price Cow/Calf Elk license. This license can be purchased by itself or **in addition** to any other **General or Limited Quota** Elk license that you may draw or purchase. **No more than one (1) Reduced Price Cow/Calf Elk license may be received. If any licenses remain after the drawing, either those applicants unsuccessful in the Reduced Price Elk drawing or first time applicants may purchase a license in the field. These licenses may be purchased from automated License Selling Agents or online at <http://gf.state.wy.us> beginning July 20, 2010.**

WARNING

A PERSON MAY APPLY FOR A REDUCED PRICE LICENSE WITHOUT APPLYING FOR A FULL PRICE LICENSE. THE DRAWING FOR FULL PRICE ELK LICENSES IS INDEPENDENT OF THE DRAWING FOR REDUCED PRICE COW/CALF ELK LICENSES. THE POSSIBILITY EXISTS THAT YOU COULD DRAW A REDUCED PRICE COW/CALF ELK LICENSE IN A DIFFERENT HUNT AREA THAN YOU DRAW YOUR REGULAR ELK LICENSE. IF CONCERNED THAT YOU MAY RECEIVE LICENSES IN DIFFERENT HUNT AREAS, ONLY APPLY FOR A SINGLE HUNT AREA IN THE REGULAR ELK DRAWING AND THE REDUCED PRICE COW/CALF ELK DRAWING.

ONCE ISSUED, NO REFUNDS WILL BE MADE FOR THE LICENSE(S).

YOUTH REQUIREMENTS

To be eligible for a youth big game license, an applicant must be at least 11 years of age at the time of application, have not reached their 18th birthday at the time of application, and be at least 12 years of age while in the field hunting.

PERSONAL DATA ELEMENTS

Please use the following abbreviations when completing your application:

EYES: Brown-BR, Blue-BL, Hazel-HZ, Green-GR, Gray-GY

HAIR: Brown-BR, Blonde-BL, Black-BK, Gray-GY, Red-RD, Bald-BD, White-WH

HEIGHT: Enter as Feet and Inches

SUFFIX: Examples are Jr., Sr., I, II, III, IV
